


How to Request electronic documents for your Brokerage Account

1. After logging in to your account on Wealthscape Investor (https://investor.wealthscape.com), click on the blue "Enroll Now" link on the bottom left of the screen under Go Paperless. Alternatively, you can click on the Service Tab, on the top right and select "Document Delivery Instructions" from the menu. Both will bring you to the same page.



2. A new window will pop up with your options for each account you have registered. Highlight the first account and select Electronic Delivery for each type of document you would like to receive electronically. Click Save this Account and then I agree. Repeat for each account.
